The home is located in a quiet residential street but within walking distance of Luton Town Centre with access to the community and benefits from the facilities in the town centre such as pubs, restaurants, a large range of shops, church and cinema. With good access to public transport networks including bus and train services.</p> <p>All service users have individual bedrooms equipped with a hand wash basin. Communal areas are shared with access to a lounge/ dining room, a domestic style kitchen and utility area, downstairs toilet with shower and an upstairs bathroom. The conservatory houses the laundry facilities.</p> <p>The home is not suited to people with reduced mobility.</p> <p>There is a front garden with some off street parking. The back garden is secure and well maintained.</p>
